* All travel/transportation is the responsibility of each family.

If my child leaves the program before April 30, 2016 I **forfeit all** payments & will be charged a **\$250 buy-out fee**.

Payment tardiness will result in late fees, and my child being sat-out of practice & replaced for competitions until the balance is paid. Unpaid balances 60 days past due will be sent to a professional collection agency.
