All payments are non-refundable. Payments are never pro-rated/refunded...including cases of illness/injury, joining late, or leaving early. **Pay-in-full prices** are discounted and therefore **100% non-refundable**. If my child leaves the team before Mar 31, 2015 I **forfeit all payments** & I will be charged a **\$250 buy-out fee**.

Payment tardiness will result in late fees, my child being sat-out of practice & possibly replaced for competitions. Unpaid balances 60 days past due will be sent to a professional collection agency.
