*\$25 late fee if not paid by Jan-15.*

## TERMS & CONDITIONS:

1. All payments are non-refundable.
2. Payments are not pro-rated for cases of illness, injury, sitting-out for late payment, or joining after Sept 2023.
3. Pay-in-full payments are discounted and therefore 100% non-refundable / non-transferable.
4. Returned check: \$30 fee & no personal checks accepted for remainder of the season.
5. Merchandise (i.e. uniform, clothing, etc) will not be distributed if ANY payment (e.g. "tuition") is past due.
6. Service will be withheld (student sat-out) if payments become 30 days past due.
7. Early termination fee of \$350 will be assessed for quitting team between October 2023 - April 2024.
8. Customer will approach staff and families respectfully, and represent CheerForce positively in public/social media.  
Failure to comply will be cause for removal with no refunds given.
9. Team members are not guaranteed specific positions or placements (e.g. "flyer", "front row")
10. Any Absence/Injury within 14 days of competition may result in being replaced for that comp.

**Financial Agreement disputes are adjudicated in California Small Claims Court. CheerForce adds a \$500 legal service fee if Small Claims Court adjudicates a dispute, regardless of outcome.**
